- 2) Serve on an active committee.
- 3) Must have a current AMA membership card.
- 4) May enter discussions at meetings.
- 5) May not vote in official RCRC matters until Membership Status is attained.
- 6) May not have flying guests until fully qualified member status is attained.
- 7) Provisional membership may be terminated at any time during the 6-month period.
- 8) Must be in attendance at the meeting in which membership is requested and the meeting in which Active Membership vote is taken.

I, the undersigned, understand that the Rockland County Radio Control Club, Inc., on behalf of its membership, obtains permits and permission to fly radio controlled model aircraft at various privately and publicly owned flying sites. I also understand that when I am present at these sites engaging in any and all activities associated with the Club membership, it is my obligation to conduct myself in accordance with the AMA Safety Code, Club Safety Rules, Club Field Rules and any other site specific rules and procedures in effect at the time. Failure to do so will result in the suspension or revocation of site access and flying privileges.

In consideration of the permission granted to me to use Club flying sites, I hereby, for myself, my heirs, legal representatives and assigns RELEASE AND DISCHARGE the flying site owner/owners, its agents and employees, as well as the Rockland County Radio Control Club, Inc., and its officers, of and from all claims, demands, actions, or causes of action I may have for personal injuries or property damage from whatever cause sustained by me while participating in Club activities, and I further agree to INDEMNIFY and HOLD HARMLESS the site owner/owners, its agents and employees, as well as the Rockland County Radio Control Club, Inc., and its officers, against any and all claims, demands, actions, or causes of action for injury to any person, and damage to any property which may be incurred arising out of the use of the Club flying sites.

I have read and understand the forgoing paragraphs, including the **RELEASE AND INDEMNITY** Provisions which have legal significance.

I REALIZE THAT MODEL AIRCRAFT FLYING IS A POTENTIALLY HAZARDOUS ACTIVITY AND I ASSUME ALL RISKS OF PERSONAL INJURY OR PROPERTY DAMAGE SUSTAINED BY ME.

In addition to the Rockland County Radio Control Club, Inc., and its officers, this Release applies to any flying site owner granting permission/permits for Club activities. The list of site owners includes, but is not limited to:

- 1) Town of Clarkstown, Rockland County, NY (flying sites at Clarkstown landfill, Congers Lake, and any other Town facility)
- 2) Renaissance Entertainment Corp, Tuxedo, NY (flying site at the ski area parking lot)
